# **Contest Disclaimer**

The views and information outlined above are of the Invasive Species Centre (ISC). By participating in the Angler Survey organized by the ISC, you acknowledge and agree that participation in ISC activities is considered 'at your own risk'.

The following conditions apply to the Angler Survey Contest:

- 1. Respondent must be a Canadian citizen to be entered into the draw.
- 2. Name and contact information must be provided for winner to receive their prize.
- 3. Entries can be submitted as a result of completing the survey.
- 4. One (1) prize, consisting of a \$100 Bass Pro gift card and items from Asian Carp Canada will be awarded to the participant whose name will be randomly drawn.
- 5. A random draw will be conducted on a selected date by the ISC.
- 6. The draw will involve all the names of those entered as a result of completing the survey by the required date.
- 7. After the completion of the draw, the winner will be notified using the contact information provided and will be asked to complete a skill testing question.
- 8. If the winner does not respond within 72 hours, a new winner will be drawn.
- 9. The prize will be promptly mailed following winner response.
- 10. The ISC does not take responsibility for any prize that is lost or damaged in the mail.
- 11. The odds of winning the draw will be dependent on the number of respondents.
